# **EVALUATORS AS PER EU PRACTICAL GUIDE**

## ARTICLE 1 – DESCRIPTION OF THE PROGRAMME

- 1.1. The Multi-Educational Programme for Employment Promotion in Migration-affected Areas (MEPEP) falls under the scope of the "Enhancing the Response to Migration Challenges in Egypt Programme (ERMCE, Ref. T05-EUTF-NOA-EG-01) which is funded by the European Union Emergency Trust Fund for stability and addressing the root causes of irregular migration and displaced persons in Africa.
  - The MEPEP Programme is aligned to the Operational framework of the EU TF North Africa Window (EUTF NAW), is implemented by the Italian Agency for Development Cooperation (AICS) in the frame of the Contribution Agreement T05-EUTF-NOA-EG-01-06 (T05.255), with a planned three-year duration.
- 1.2. The Programme aims at enhancing economic and equal opportunities, in particular for vulnerable groups by improving the quality of the Technical and Vocational Education and Training (TVET) system in Egypt.
- 1.3. The Programme will be implemented in Sharkeya Governorate as its target area in consultation with local authorities. This area hosts the 10th of Ramadan Training Centre belonging to MoTI's Productivity and Vocational Training Department (PVDT) that will be the target of the activities. This Technical School was chosen during the formulation phase by AICS Cairo together with the local Authorities.
- 1.4. The technical and physical infrastructure as well as the equipment of this Technical School will be enhanced to host a modern VTC in the industrial area of 10th of Ramadan City implementing a refurbishment of existing laboratories/workshops/classroom and building a new edifice to increase the number of laboratories and classrooms.
- 1.5. The Italian Agency for Development Cooperation (AICS) Cairo Office will work in close cooperation with the Ministry of Education and Technical Education (MoETE) and the Ministry of Industry and Trade (MoTI), namely the Productivity and Vocational Training Department (PVDT), as the main national entities mandated in the area of TVET.

### ARTICLE 2 – PURPOSES

2.1. The Italian Agency for Development Cooperation (AICS) in Cairo, with the financial assistance of the European Union, intends to set up a list of evaluators to support the evaluation committee in the selection of Contractors for Works Contract as per EU Practical Guide.

## ARTICLE 3 – SERVICES

The evaluator is bound by a declaration of impartiality and confidentiality to be signed before starting the assessment. If an evaluator believes there might be a situation of conflict of interests in relation to one or more applicants, he/she must inform the contracting authority immediately. In addition, strict confidentiality is required from the expert involved in the implementation of this contract, notably on the evaluation of individual tender.

- 3.1. The evaluators are appointed as member of the opening and evaluation committee (please refer to the following link for further information: https://wikis.ec.europa.eu/display/ExactExternalWiki/5.+Works+Contracts#id-5.WorksContracts-5.3.8.Theevaluationcommittee).
- 3.2. Evaluators will work under the supervision of the chairperson of the evaluation committee.
- 3.3. The evaluation committee must use the administrative compliance grid and the evaluation grid published in the tender dossier.

# <u>ARTICLE 5 – ELIGIBILITY</u>

- 5.1. Expert(s) engaged by the tender may be of any nationality.
- 5.2. Candidates, tenderers or applicants will be excluded from participation in procurement procedures if:

  a) they are bankrupt or being wound up, are having their affairs administered by the courts, have entered into an arrangement with creditors, have suspended business activities, are the subject of proceedings concerning those matters, or are in any analogous situation arising from a similar procedure provided for in national legislation or regulations;
  - b) they, or persons having powers of representation, decision making or control over them, have been convicted of an offence concerning their professional conduct by a judgment of a competent authority of a Member State which has the force of res judicata; (i.e. against which no appeal is possible);









- c) they have been guilty of grave professional misconduct proven by any means which the Contracting Authority can justify, including by decisions of the European Investment Bank and international organisations;
- d) they are not in compliance with their obligations relating to the payment of social security contributions or the payment of taxes in accordance with the legal provisions of the country in which they are established or with those of the country of the Contracting Authority or those of the country where the contract is to be performed;
- e) they, or persons having powers of representation, decision making or control over them, have been the subject of a judgment which has the force of res judicata for fraud, corruption, involvement in a criminal organisation, money laundering or any other illegal activity, where such an illegal activity is detrimental to the EU's financial interests;
- f) they are currently subject to an administrative penalty referred to in Article 103(1) of the Financial Regulation (for budget-funded programmes)/Article 99 of the Financial Regulation (for 10th EDF-funded programmes).

### ARTICLE 6 – QUALIFICATION REQUIREMENTS

- 6.1. Master's level university degree in Architectural or Civil Engineering (level 7 European Qualification Framework EQF and/ or a similar certification from valid from the country of the expert). Other Engineering Specialization in Mechanical and Electrical disciplines of the same level may be taken into consideration if accompanied by sector-specific experience.
- 6.2. Be proficient user in English language (C1 Level Common European Framework of Reference).
- 6.3. Be registered at the Engineers Syndicate/Board of Engineers of the country of residence for the last 10 years.
- 6.4. A minimum of 15 years of proven experience in construction of building works of new/renovation of building projects (educational premises preferred).
- 6.5. Have carried out in Egypt over the past 6 years at least one contract as evaluator of Works Tenders preferable submitted under EU rules and regulations.
- 6.6. Expertise will be checked against CV.

# <u>ARTICLE 7 – MODALITIES FOR PRESENTA</u>TION

- 7.1. Evaluators shall express their interest by submitting the following documents (no additional documents are requested at this stage):
  - a) dated and signed Expression of Interest (ANNEX A);
  - b) dated and signed Curriculum Vitae in English (Europass format is recommended), including authorization to process personal data;
  - c) proof of enrolment in the Engineers Syndicate/Board of Engineers of the country of residence;
  - d) scanned copy of a valid Identification Document;
- 7.2. Documents may be submitted:
  - a) by email (PDF format not editable, enclosed in an electronic outer cover note with the reference as per point 7.3);

- 7.3. The outer cover note must bear the following reference: Call for Expression of Interest as Evaluator for MEPEP Programme ref: T05-EUTF-NOA-EG-01-06 (T05.255) ECP13.2023.

## ARTICLE 8 – RULES FOR THE REGISTRATION IN THE LIST

- 8.1. The Contracting Authority will first evaluate the following:
  - a) Compliance with the submission deadline. If the deadline has not been met, the Expression of Interest will automatically be rejected.
  - b) Eligibility as per Article 5.
  - c) Qualification requirements as per Article 6.
- 8.2. Eligible applicants, meeting all qualification requirements, will then be inserted in the list in an alphabetic order. The list does not represent any classification and the related insertion does not imply any rights to be committed the contracting authority to implement the contract.

#### ARTICLE 9 – SELECTION PROCEDURE

- 9.1. Eligible applicants, meeting the relevant qualification requirements, will be invited to submit their financial offer along with an Integrity Agreement and the required statements as per EU PRAG.
- 9.2. The selection procedure will be objective and follow the principles of non-discrimination and equal treatment.
- 9.3. Successful applicants will be invited to provide the documents required for the registration as AICS economic operator (see https://ilcairo.aics.gov.it/amministrazione-trasparente-registro-operatori-economici-il-cairo/).

# ARTICLE 10 – PERSONAL DATA

10.1. If processing your reply to the Expression of Interest involves the recording and processing of personal data (such as names, contact details and CVs), they will be processed solely for the purposes of the management and monitoring of the tender and of the contract by the data controller without prejudice to possible transmission to the bodies in charge of monitoring or inspection tasks in application of EU law.
