The Italian Agency for Development Cooperation – Cairo Office (hereinafter AICS Cairo) puts up for auction the following car:

The car is PERFECTLY WORKING AND in EXCELLENT CONDITIONS. See picture at the end of this document

The car is registered with a diplomatic plate, but it was purchased on the local market, thus the car is **free from duties and custom fees.**

An information session for potential bidders with the possibility to view the car will be held on Thursday 13 April at 12 p.m. at AICS Cairo Office, 1081 Corniche El Nil, Belmont Building 4th floor, Garden City, Cairo.

Potential bidders should express their interest to participate by **sending an email to the address segreteria.ilcairo@aics.gov.it not later than 12 April 2023.**

1. Conditions

The vehicle in question will be offered for sale in its current state of fact and law. AICS Cairo will not be responsible for any hidden defects of the vehicle sold; therefore, the successful bidder will not be able to raise exceptions in this regard.

The buyer will be responsible for any burden related to the possession and use of the goods, according to current regulations (any testing, registrations or anything else).

The successful bidder shall take care of all necessary formalities for the transfer of ownership and any other procedure relating to the use of the vehicle, without anything being due by AICS Cairo Office.

2. Auction base price.

The starting price of the auction is set at EUR 3,000.00 (three thousand euro).

3. Auction implementation modalities.

- a) The auction will take place with the submission of secret bids equal to or higher than the starting price.
- b) Bids must be received by the Protocol of AICS Cairo Office in a sealed envelope with the words: "Suzuki Vitara purchase offer".
- c) The auction, without prejudice to the provisions of the general conditions, will be declared desert if one valid bid at least is not submitted.

4. Terms of participation

In order to participate to the tender, interested parties must send, under penalty of exclusion, the economic offer by filling in the [form "Annex A"](#) to:

The offers should be delivered no later than 3 pm on 20 April 2023

These offers can be delivered by hand at the aforementioned Office from Sunday to Thursday from 9 am to 3 pm (proof of deposit will be provided by issuing a receipt), or delivered, at the sole risk of the bidder, by registered mail. In any case, the date of receipt and the time set by the AICS Cairo Office will prevail.

The date of shipment of the registered letter will not have any relevance. AICS Cairo Office is exempt from any responsibility for non-delivery or delay in delivery or delivery of the package, whatever the cause that determined it.

5. Inadmissibility of proxy offers.

Offers by proxy are not allowed, except in the case of legal representatives of public and private legal entities and companies that carry out entrepreneurial activities.

6. Submission of the offer.

The offer must be received within the deadline referred to in point 4, paragraph 3, in a closed envelope, as specified below:

The envelope, to ensure its integrity, must be sealed and countersigned on the closing flaps.

7. Public session for the opening of tenders.

The Evaluation Commission appointed for this purpose, **on 24 April at 11 am**, in public session, open to competitors who have submitted a bid, proceeds to open the packages and examines the documentation attached to them.

The award, without prejudice to the provisions of the general conditions, takes place in favor of the person who has submitted the greatest offer and even when there is only one valid offer, provided that it is considered suitable and adequate.

The price offered must be equal to or higher than the price indicated at the starting price. Lower bids will not be accepted.

Tenders made conditional or expressed indefinitely or with simple reference to another offer of one's own or others are not permitted. The offer must be expressed in figures and letters; in case of discrepancy, the most advantageous amount for the seller will prevail.

8. Parity of tenders received. Higher bids.

In the event that two or more competitors make the same bid, if present during the public session, they will be invited, by the method of secret bids, to formulate a new offer during the same session, provided that they agree to this modality. In case of lack of simultaneous presence or failure to agree for the immediate formulation of new offers, the same competitors will be invited, by email or telephone communication, to submit a new offer within 2 days of the meeting, in the same manner as for the first offer.

Once the envelopes have been delivered, the winner will be declared the one who will be the highest bidder. If the tenderers who have produced the same tender do not agree to improve the tender, or the new tender is again of the same amount, the successful tenderer will be chosen by draw.

9. Effects of the award report.

The award report will not have the effects of the sale contract, it will therefore be necessary to proceed with the signing of the deed of sale in the manner that will be subsequently communicated.

10. Terms of Sale.

The vehicle is alienated in sold in its current state of fact and law.

The vehicle will be made immediately available from the signing of the sale contract.

11. Obligations of the Buyer and the Administration.

The buyer will be considered obliged for all reasons with the signing of the deed of sale.

12. Buyer's Waiver.

In case of renunciation or if the final successful bidder does not appear to sign the purchase contract within the deadline communicated, he will forfeit all his rights. In this case, AICS Cairo Office reserves the right to evaluate the award of the asset in favor of the second highest bidder or to activate a new procedure.

2. Time limits for the conclusion of proceedings.

These proceedings will be concluded within thirty days of the publication of this notice.

3. Personal data processing and storage.

The processing of the data received, which is a condition of participation in the auction, will take place only for the purposes referred to in this auction notice and in accordance with Legislative Decree 196/2003 and other current regulatory provisions.

It should be noted that the processing of personal data will be based on lawfulness and correctness in full protection of competitors' rights and their confidentiality. The same data will be kept in the records of AICS Cairo Office for administrative and accounting control purposes only and in any case for a time not exceeding that necessary for the purposes for which they were collected and processed.

4. Disturbances.

The terms of the respective Penal Codes will be taken against anyone who, by violence or threat or with gifts, promises, collusion or other fraudulent means, prevents or disturbs the tender, or removes the bidders and against anyone who refrains from competing for money or other benefits to him or to other date or promise.

5. Place of jurisdiction

In the event of disputes, the exclusive place of jurisdiction shall be Cairo.
