General Clarifications by the Contracting Authority

Request for Clarification 1:

Regarding the ceramic required is the ceramic type and what is the ceramic dimensions for the walls and floors?

Answer:

- Type of ceramic is Venezia ceramic or equivalent type , regarding ceramic dimensions : for floor 40cm*40cm or 50cm*50cm & for wall 20cm*20cm.

Request for Clarification 2:

For Assiut governorate regarding the supply and installation of a marble sign the quantity is only 1 sign and there are 5 vet units is it only one sign?

Answer:

Request for Clarification 3:

Regarding the metal gates supply and installation there is no description dimensions or weight

Answer:

Regarding the interlock floors and the sidewalks there is no item for it.

Answer:

- *The item for interlock floors and the sidewalks is already included for nitrogen unit in Sohag and Assiut.*

Request for Clarification 5:

Regarding the equipment that the animals in the vet to give them injections and meds it has no item even though they need repairing and needs flooring and also new units.

Answer:

- *Regarding the equipment that the animals in the vet to give them injections and meds (Squeeze Chutes) it have been added to the items in the excel document VOLUME 4.3.2 BILL OF QUANTITIES for the veterinary units in the three governorates (attached).*

Request for Clarification 6:

Regarding the Reinforced concrete flooring there is no description for the iron network also no description was given of the iron mesh (numbers and diameters), thickness, or type of tarpaulin beneath the concrete.

Answer:

-*The thickness of Reinforced concrete flooring is 15cm ,iron mesh will be 5φ10/m and tarpaulin beneath the concrete will be Polyethylene 100 micron and it have been added to the items in the excel document VOLUME 4.3.2 BILL OF QUANTITIES.*
